

To Whom This Applies with All Respect.

As I've communicated several times the MAINE CPS is a criminal organization and not just broken or corrupt. As if the issue of MAINE CPS Supervisor; Jack Waite, being directly involved in witness tampering and of promises of my co-parent being given the children immediately (Attached). That's enough to make any person of any kind of ethical values understand the undermining of the U.S. Justice system and that the Federal Authorities including the Office of Inspector General of the United States located in Washington D.C. have authority of any civil case in the United States. The penalty of trying to undermine the justice system comes with a heavy penalty.

Prior to this occurrence of criminal activity, the State of Maine CPS is violating the ADA act of which it was notified of in a report from the Department of Justice in June of 2022. In that time frame, the statistics of the Maines CPS system shows it's not only visually broken but has operated outside of rules of law, Constitutional and Federal rights and continues operations of blatantly and flagrantly outside the rights of both these children's parents, the children themselves, and are destroying years of therapeutic trauma therapy that will take years to overcome.

Against all my values, ethics, and personal choices which has included years of abuse from different CPS organizations in each state I've lived in. The lack of oversight for the continuous violations of parent's rights in Maine and the number of deaths of children in care of the Maine CPS system (99) in the last four years is criminal. My children who are protected under the ADA act and of Native American heritage do not belong in a foster home full of children. I have been a therapeutic parent for many years, and I can almost tell you exactly what their behavioral outbreaks are like right now. But instead of reuniting these children who have been snatched from their respite care worker, *Nola Gervais, which was paid for by the paternal parent*, by case worker Monica Lee. They transferred this to another case worker named Samantha Short. When I started this paragraph, I violated everything I said I would not do to harass me and for the love and safety of Micah & Gabriel, I went to your scheduled drug test. I promised myself that 20 years of this harassment would end here and now in Maine, but instead for my children I went to the testing site and after a conversation with the collector and identification of his credentials complied with the most intrusive urine screen minus areas of places this organization will ever see. The fact that it was ordered that "I drop my pants and underwear to my ankles and pull my shirt above my chest" was unbelievably the exact harassment I swore to myself to never be

experience too. However, I give a lot of credential to the communication techniques the collector was equipped with because of that I did comply with the harassment request from Samantha Short. It's people like this gentleman that should be in supervision at Maine CPS and not corrupted power freaks. Once the testing was completed and all protocols for chain of custody were completed. I wanted to show the collector the prescriptions and dates and medications I received a print off and he communicated that he did not take any paperwork but DHHS was nearby so I could take it there to expedite the stoppage of abuse to my children.

When I entered the DHHS parking lot and parked my jeep I grabbed my prescription list printed today and attached with this email. I grabbed my paperwork of over a decade of drug testing, most of which was far outside the realms of "peeing in a cup"! I brought my professional resume with over 30 years of education and experience including being a social worker. I brought my cover to my novel which is also attached to this email chain as well (Don't mind the officer's names on the page; they were professional and as confused as I, but we will get to that in a minute). I also brought a drug treatment program I wrote myself as a drug counselor. So as being a drug counselor and one who has not only witnessed addiction first hand but has counseled others, spoke at Universities and colleges, churches, reform schools, half-way house, county jails, and numerous other speaking engagements; questions why someone who has yet to have any mental health evaluation, any adult psychosocial evaluation, any type of anything but without knowledge of anything about me; Samantha Short, felt it was in the best interest of all involved for me to take the most frequency and most intrusive urine screening without even speaking one word to me or one word from any professional health service. This leads me to believe that you, Samantha Short, are guilty of violation of the ADA act and other Constitutional, Federal, and Maine State policies and procedures.

So, let's get back to both the professional officers who were called to the Lewiston Maine DHHS office. I see the officer walk in and thought well, I'm sure the woman in the back row vaping is going to be in trouble but instead the officer asked if I was Thomas, and we walked outside. The officer said they got a call about "threats" and asked for my Identification which he walked inside the office with. I stood outside with another officer that was immediately dispatched to the scene. While the other officer was outside I communicated that I was here to drop of my prescription list printed today (10/28/24), and other items that I felt would

make the case worker look out for the best interest of these children to return them to their parents who have co-parented for over 18 years. Probably more but *for a minute* as they say in “Alabama”. Attached with this email is a picture of how many days I’ve been clean. Y’all can kiss my ass for making me relieve trauma and all that I have had to endure because of being ethically lacking persons who try to force conditions on a person that they have no idea of what this family has been through! Not to mention THE DAMAGE BEING DONE TO OUR CHILDREN!

So as the officer returns with my Identification, he says that I’ve been asked to be trespassed for making threats. I explained that all I did was ask for Mrs. Short and her Supervisor and if her supervisor wasn’t there then the next one in line would do. I wanted to give her my prescription list and ask what it would take to expedite whatever hoop they wanted me to jump through even though I swore on my soul that I would never degrade myself to this, but for my children ANYTHING TO KEEP THEM SAFE!

P.S. The FOIA request about the phone call should clear up what ever threat that Mrs. Short felt the need to communicate with the police instead of taking my prescription papers today after I complied with the intrusive drug test collection (which is clean btw!). Guess when then information is available, I will share.
