Nigel is here with a DHS worker for a well check/weight check. He was taken into custody four days ago. A referral was made by a neighbor that saw Nigel and his brother through window said they were small and undernourished. When DHS went to the home, the parents wouldn't cooperate or let them in. DHS went back to police and then the sheriff came back with and order to go into the house and the parents opened the door. When the police went in to get the kids, the mom was screaming to not take the kids. The kids "didn't seem phased by mom screaming" and went out of the house without reacting. DHS has only been able to find medical records up to 2017 for the kids. DHS was involved with this family in 2016 for FTT for brother. The kids were taken to the ER after leaving their home and have been moved to a kinship foster home. They have a hearing tomorrow.

When Nigel eats he tries to shove as much food as possible into his mouth, he tries to eat food from the ground and trash can. Both he and his brother flinch when touched. He is nonverbal. Parents won't allow the kids to be immunized.
